Subject: Final Review of Health Life Safety (HLS) Survey

At the October 11, 2016 and October 24, 2016 Board of Education meetings, the administration and Studio GC reviewed with the Board changes and updates to the Health Life Safety Survey (HLS). Items that did not fit within the HLS requirements were removed from the plan. Tonight, the administration and Studio GC will be reviewing with the Board the items that remain on the HLS list (Attachment 1) and need to be completed within the next five years.

Items that were completed during summer 2016 are still included in the HLS report, so that we can show that we have completed these items. You will note that even although the District completed over \$5 million in capital improvements during summer 2016, only a very small percentage of these were actually on the HLS report. A majority of the work is on the critical infrastructure projects list, although it could have qualified as HLS. Placing these items on the critical infrastructure list rather than HLS allows the Board the ability to perform these repairs/renovations as funds are available. In contrast, "A" and "B" projects on the HLS list must be completed within five years of the filing of the HLS with the Illinois State Board of Education (ISBE).

Although a majority of our projects are on the critical infrastructure list and not on the HLS, the administration is committed to bringing these projects forward to the Board for approval so that our buildings are safe, warm and dry and we preserve the largest asset in the District, our nine buildings.

In the HLS report there is a column labeled Estimated Completion Date; Estimated Costs have been escalated by 5% each year beyond summer 2017. These are estimates; as projects are bid, we will then have actual costs. Below is a summary breakdown by building and code for the Board's review.

Per ISBE, a straight 10% is added onto the construction costs for architecture, construction management, etc. fees. The District is currently paying Studio GC 7.5% for architectural fees and 2% for construction management.

The final HLS will be brought to the Board for approval and submittal to the ISBE at the April 24, 2017 Board of Education meeting.

Area

As authorized at the November 28, 2016 Board of Education meeting, District 64 prepared construction documents and sought bids for the Lincoln LRC and Secure Vestibule/Office Area. Both of these projects were included in the estimated \$5.3 million in projects approved for bidding for summer 2017.

Bids for the Lincoln Middle School LRC and the Secure Vestibule and Office Area were received at 10:00 a.m. on Friday, March 24, 2017. The District received bids from seven contractractors. The bid package had two options:

Base Bid 1 - LRC Only

The lowest responsible base bid was from Construction Solutions of Illinois in the amount of \$582,723. If the Board votes to only do the LRC, the administration and Studio GC are recommending accepting Alternate #3 at a cost of \$17,500 and Alternate #4 at a cost of \$17,500. The definition of both Alternates is included at the bottom of the Bid Tab Worksheet (Attachment 1) for a total cost of \$617,723. The initial estimate for this project before fees was \$580,822. This represents a difference of \$36,901 for the LRC project when the alternates are included.

Base Bid 2 - LRC, Secure Vestibule and Office Area

The lowest responsible base bid was from Construction Solutions of Illinois in the amount of \$1,123,723. The administration and Studio GC (Attachment 2) are recommending accepting Base Bid 2, Alternate #3, \$17,500 and Alternate #5 \$24,000 for a total project cost of \$1,165,223. The initial estimate for this project before fees was \$1,568,110. This represents a savings of \$402,887 from the initial estimate of the complete LRC, and Secure Vestibule and Office Area package.

The redesign of the Secure Vestibule and Office Area by Studio GC eliminated the need for a small addition to Lincoln Middle School. Eliminating an addition is always a cost savings; there is no need to dig foundations and meet the water runoff requirements for the City of Park Ridge. Combining the projects and completing them at the same time is also a cost savings, as the administration and Studio GC have shared with the Board at past meetings.

Related to this work, the District will incur architectural fees of 7.5% and construction management fees (estimated at 2%) for this project, as reviewed at the November 28, 2016 Board meeting. The fee is approximately \$111,000 for Base Bid 2 and is all inclusive from bid documents to completion of project. If the Board chooses only the LRC, Base Bid 1, the fees would be approximately \$58,700.

Recommendation and Financial Overview

The Board's action tonight is the culmination of more than a year of discussion, review and deliberation. The LRC renovation will better support future-ready learning and provide for flexible use of the space as foreseen in the 2020 Vision Strategic Plan. The space would accommodate a minimum of three different configurations, which were shared with the Board at the March 27, 2017 meeting. Configurations include the basic library with tables and chairs; collaborative study areas for three different groups of students; and a large team instruction space, among the many options that will be used in coming years to better meet the educational needs of Lincoln students and staff, and its community.

The redesigned secure vestibule is being proposed for an existing entry on Crescent Avenue immediately adjacent to the LRC. The project would include re-orienting the office -- without expanding its footprint -- to directly oversee the vestibule. By working with Studio GC, the vestibule was redesigned from an earlier proposal to omit a small addition originally considered for that location. This revised plan has eliminated the need for more costly exterior and site work, while still providing an accessible and secure entry. A major added benefit to this work is making the existing office space function far more efficiently to meet the daily needs of more than 800 students and staff members at Lincoln, and the many hundreds of visitors it receives each week.

Administration believes that accomplishing both projects at the same time will be a significant improvement to both the safety and efficiency of the school and will provide an active learning space for students that will only expand in importance in the years to come. This investment in Lincoln, as one of the District's oldest buildings dating to 1928, is overdue and when combined with the new windows, roofing and other critical infrastructure projects will ensure the school can continue providing a quality learning environment for students now and in the future.

As a reminder, funding for the LRC and secure vestibule had been included in the Financial Framework at the original estimated amount of more than \$1.5 million. Approval of both projects tonight will mean a savings of \$402,887 from that estimate, which can in turn be invested in other projects identified on the five-year plan.

Alternate motions have been prepared for the Board's consideration. Administration recommends that the motion for Base Bid 2 with its alternates be adopted.



Following a major update required by changes in state law last summer, you will note very few revisions are being made to these student behavior materials at this time.

Specific announcements and materials within the handbook also fulfill many of the District's varying annual legal notice requirements.

The handbook contains a wealth of District and school information, such as: the school year calendar; Board of Education meetings and information; District operations and the Strategic Plan; day-to-day school essentials; communications and safety; travel to and from school; academics; school health services; student behavior expectations; and information on our related organizations. Roster pages with each school's specific facts and key calendar dates are omitted for the April posting, but are distributed to families separately in August.
