We use beyond the bell 5 days a week, before and after school. On the days that we are working from home, we do not have the time to make sure our kids are logged in, are staying on task, etc., much less to be the ones teaching our children as we had to do in the spring. We barely made it through the spring e-learning when we were only working from home, but we are back to normal work schedules. What is the district prepared to do for families in our situation? Will the district financially assist families to hire tutors, a nanny, etc. to cover for the lack of in-person education, and before/after care that families with two working parents depend on receiving. The tax paying families in the district are paying for 5 day per week in-person instruction, with fully staffed buildings and the required utilities and supplies to operate them. This re-opening plan fails to meet these needs.

Questions/comments regarding reopening plan for D64

Dear School Board and administration,

First of all, thank you for the time and thoughtfulness that you are putting into plans for our schools. These are unprecedented times and we recognize that everyone is doing their best on behalf of the community. We have some questions that we hope will be addressed at the board meeting this evening.

- 1. With comparable districts such as Arlington Heights district 25, Mount Prospect district 57, Glenview district 34, Buffalo Grove, and Elk Grove starting with remote learning, what is it about District 64 that is unique and warrants beginning with in person instruction rather than remote?
- 2. Expecting teachers to simultaneously teach to an in-person audience as well as a remote group of students at home seems as though it will decrease the effectiveness of both of these modes of instruction. Given the risks of having faculty and students in the building, is there actual benefit to this hybrid model in which teachers must focus on teaching to a remote audience instead of maximizing their time with students who are in the room?
- 3. Will teachers be given additional time with a delayed start to the school year so that they can completely adapt their curriculum? Teaching in this model will require an overall of curriculum, and teachers will need time to prepare.
- 4. What will happen when teachers need to quarantine due to exposure to COVID-19? Will their class have to move to all remote learning? Will the teacher be expected to stream and project their lesson into a classroom of students sitting and watching a giant computer screen?
- 5. Will the district consider shifting to a more robust remote learning model that dedicates teachers who are familiar to a grade level to teach 100% remotely to students that have chosen a full-time remote option? It is difficult for parents to make a choice of the hybrid model and remote learning model given the complete uncertainty of how high quality the remote learning model will be. Personally, if we could ensure that a teacher familiar with the grade would teach 100% remote to a class of students remotely, I would make that choice. Unfortunately, knowing that my child, if remote, could only be watching a teacher teach to live students most of the week, remote learning seems like a poor model. Lessons that are developed for remote learning are very different than live lessons. If remote, teachers need resources to do it well, time to prepare lessons using new technology, and consistency to do it well.
- 6. At the time the D64 survey was sent, the data for our country and state was in a much different spot; cases were declining and we were headed in the right direction. It is now a very different time. While I responded to the survey and said that I would send my kids for 2 days a week, I no longer feel as though this is the safest option. Have you considered sending a new survey given the current trend in rising cases?
- 7. As the CDC suggests, masks are a defense that protects others, not one's self. Is the district going to do anything above simple cloth masks and plexiglass and attempts to maintain social distancing to allow faculty and students to better protect themselves i.e.

provide N95 masks to counter the inability to follow full social distancing guidelines and precautions(6', outdoors, extended exposure time)?

I believe that a hybrid model is a good one to have in mind for WHEN we may be ready to start in-person learning. I believe that given the current data in the state, a robust remote learning model is a priority. One illness of a faculty member, student, or family member of a student that leads to even one death is one too many.

Public Comment

Dear Dr. Olson and the District 64 School Board Members.

I would like to thank you for all of the work that you have been doing since the Covid-19 Pandemic started last March. It must be very difficult to be in the situation that you are in and I would like you to know that I appreciate what you have been doing.

I would also like express my perspective and then ask a few questions about your plan.

I am the Building and Grounds Director in a neighboring school district. My district has already chosen the path of remote learning. As the B & G director, I see the difficulties in adequately preparing the classrooms to be a "safe environment". After working on this for months, I would like to say, that with all of the variables, it is virtually impossible to create a completely safe environment for the students to return to school. Despite our best efforts to make them safe, schools are not at this time. The first day of school, we have no idea which students may be carriers of the virus and there are no precautions that we can put in place that would prevent so many variables that could spread the virus. The statement that children are lower in cases or have very low rates of spreading are skewed. The students of Park Ridge have essentially been on lockdown since March. In recent times, children have returned to camps and we've seen those rates rise. What do you think will happen when students return to school? What about the safety of the teachers. Some classroom teachers with immune systems that are compromised, teachers that have and are currently fighting cancer, teachers that have MS? The wife of a friend of mine contracted the virus and has been ill for 58 days! What is the plan if one of our teachers becomes ill for an extended period of time? The district has had trouble in the past finding subs, so who will be subbing for these teachers? Many subs are retired teachers that will probably not sub in a school during this pandemic. What about the specials teachers? The specials teachers at my daughter's school see more than 500 kids in a week! In a single day, these teachers could potentially see 70 students. Even if they are traveling to each room,

they could be exposed and carry it to another classroom. Classrooms are small and poorly ventilated.

The district has invested in technology that will provide a greater version of e-learning than in the Spring. And teachers will be more prepared. I understand that e-learning is not ideal, but it is safe.

My last question is, will the students at school basically be doing remote learning in the classrooms because they will not be able to share classroom books, learning games or have papers passed out?

Public Comment for D64 meeting

Dear Board Members,

After reading our back to school plan, we were disappointed that we are not phasing in slowly, starting with full remote learning first for all. Other districts, like District 212 (Rosemont, Franklin Park etc), are currently revising their prior plans for 50% hybrid start to an all remote learning start.

As the numbers in surrounding states climb, and with many going on last minute summer vacations to neighboring spiking Covid states and playing in summer sports leagues, We feel it would be better and more risk averse if we started the year remote, at least for a month. A phase in with remote start would be best for protecting students, teachers and staff, while establishing rapport between the teachers and students on a level basis. The fact that the remote plan has 3 different options depending on how many students opt in causes a divide in the quality of the education and inequity. If all the D64 resources were put into a remote plan and everyone does this, there is less chance for inequity in learning.

Of course, exceptions could be made for only the students with high need, such as IEP students. Perhaps in small cohorts they could meet 2x in person per week for intervention.

Finally, what happens when the staff, teachers or students contract COVID and have complications from the hybrid start of the year? That person could argue that D64 is at fault because we could have gone full remote to start and chose to go ahead with in person, unlike other similarly situated close school districts. What happens when some students are unhappy with the remote plan as directed and feel like they are not getting the same education as the hybrid?

The most conservative and risk averse plan is to start out remote and slowly move to in person. If you don't start like this, it looks like future exposure to litigation for the district.

I feel like the reopening plan does a good job giving details about the cleaning guidelines that the school will follow; however I'm concerned about the lack of details when it comes to acceptable mask usage and air ventilation/circulation. It seems like the science that has come out has said that yes, the virus is transmitted via touching surfaces, but that the more concerning route of transmission is via air/droplets; therefore, I would think the topic of ACCEPTABLE masks and air ventilation should have been discussed more.

- 1. Is there a reason there are not details around mask usage like how it must cover the mouth AND nose, or why neck gaiters/buffs are acceptable (when multiple sources say they are not useful), or how the VENTS in masks should NOT be allowed? Return to School

Please consider going remote for at least the first trimester of school.

Opening schools now means that we are putting individuals at risk of serious injury or death. And for what? While no one would argue that remote learning is superior to our regular course of in-person instruction, that quality instruction is not what is going to happen under the hybrid learning model. Not a question as much as I feel it is important to include the thoughts of an anonymous D64 teacher into the record of tonight's meeting. Thank you.

"Overall, my mind is spinning with the logistics of it. I am not sure if any of these "random thoughts" will be unique, but you are welcome to use them. I would prefer to be anonymous. Thank you!

So, here goes my randomness:

- 1. I know that every classroom is going to have desks instead of tables. It isn't possible to fit all of the desks into the classroom spaced 6 feet apart. There simply isn't not enough space. So, will they decide to put in less desks or fit them in closer to each other?
- 2. It has been suggested that the school would all wash hands as a minimum at the start of the day, before and after lunch, and at the end of the day. We don't have enough hand washing stations to efficiently do this at one time. This will be a huge task since only a few can go into the bathroom at one time and many classrooms do not even have a sink.
- 3. Simply going to the lockers will need to be staggered because they are too close together.
- 4. I worry that kids are kids, and will they actually keep their masks on all day? I worry that a student might display signs of being sick, and then the entire class might have to quarantine for 2 weeks? Does that mean that the siblings' classrooms of my students also quarantine? It seems like there would be a domino effect between classrooms. Due to this, I feel that we will be switching from remote learning to in-person often. Won't that be more confusing and damaging to the students?
- 5. Just the simple classroom procedures seem monumental and risky. If collecting papers, I have heard from different sources that I should wait to touch them 24 hours later and some say wait 72 hours. Which is it for my safety? I can't sharpen pencils all at once because I will cross contaminate pencils. So, I also need to consider a safe way to sharpen and redistribute pencils, so that the students can continue to keep their own supplies at hand. I am envisioning countless hand washing between sharpening each student's pencils in order to keep everyone safe. Simple tasks like this will be very time-consuming.
- 6. As of right now, the kids will not be leaving the classroom but the specials teachers will be coming to them (except for PE). Due to space, we have lost our classroom meeting rug, and I fear that the students will be at their desks for the majority of the day. I do not know how they will sit for that long. They desperately need movement and this is not best practice.
- 7. I realize that there is a push to get kids back to school and to get back to learning, but we still won't be able to return to normal teaching. Due to the restrictions, small group work will be extremely difficult and/or impossible. So, whole group teaching will most likely occur which does not meet individual needs. So, even if we are back to school with the thought that we are going to "close the gap from the spring," I fear that kids will fall further behind with this model. With remote learning, a teacher could set up small group sessions. This still is not ideal, but it does allow for different content to be taught to different students.
- 8. What if I get sick or if one of my own children gets sick? If I need to quarantine for myself or my family, then will it be possible to get a sub in these conditions? I am imagining that it will be difficult to get a substitute teacher to come into a school setting.
- 9. When eating lunch, we will be unable to use the lunchroom and will most likely be in the classrooms. Will there be deep cleaning provided before the students continue their day? How will recess be supervised and monitored so that it will be safe?
- 10. Will the school provide masks for students who have forgotten theirs? Will the school provide cleaning supplies for each teacher in his or her classroom? Will we be allowed to use hand sanitizer in the schools again when the sinks are not available?

As you can see, my thoughts are about many different things, and there may be more in the future. I am not sure if any of this helps, but I greatly appreciate the support of the parents. I pray that we can all find a safe way to navigate forward."
